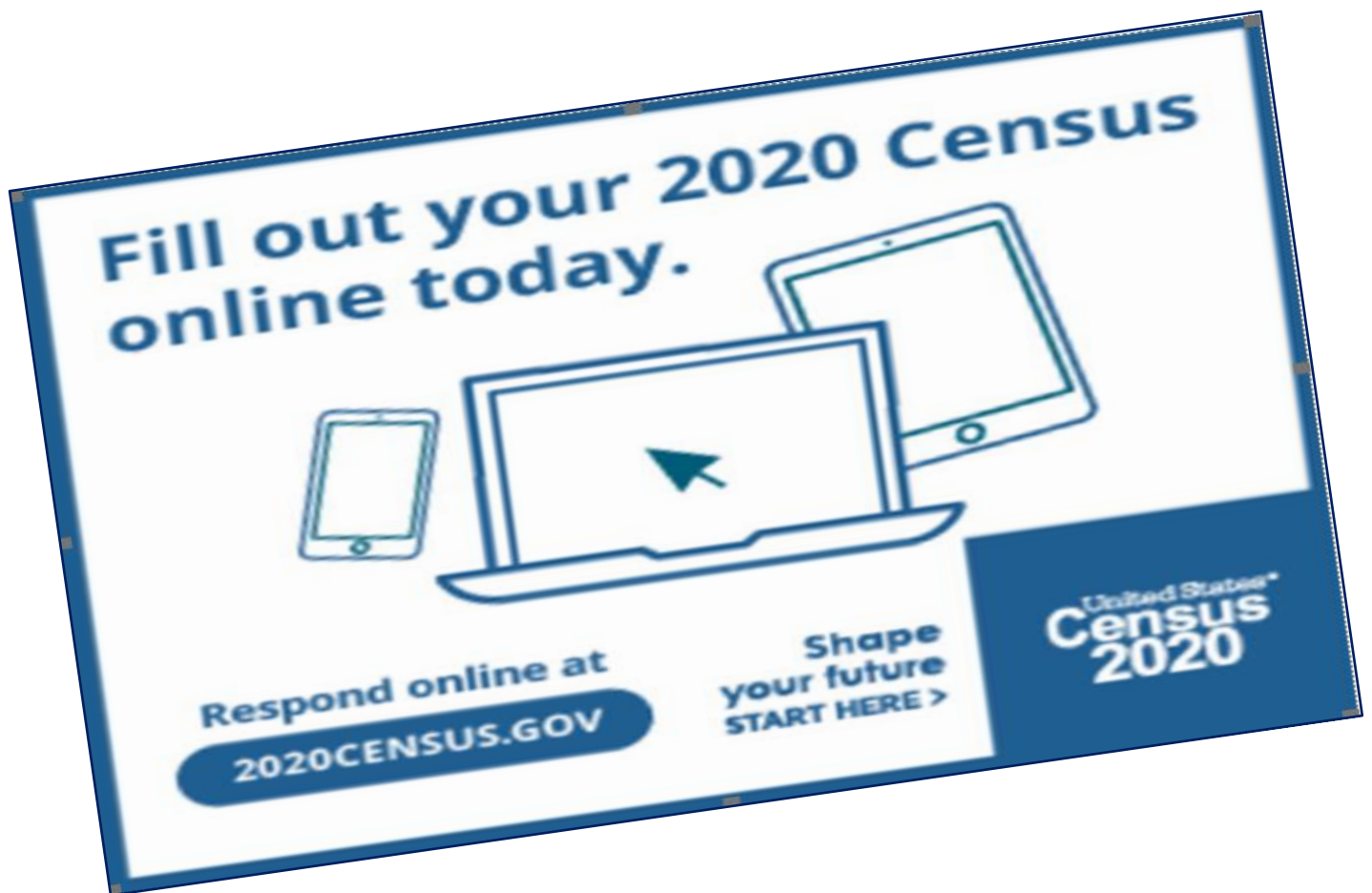

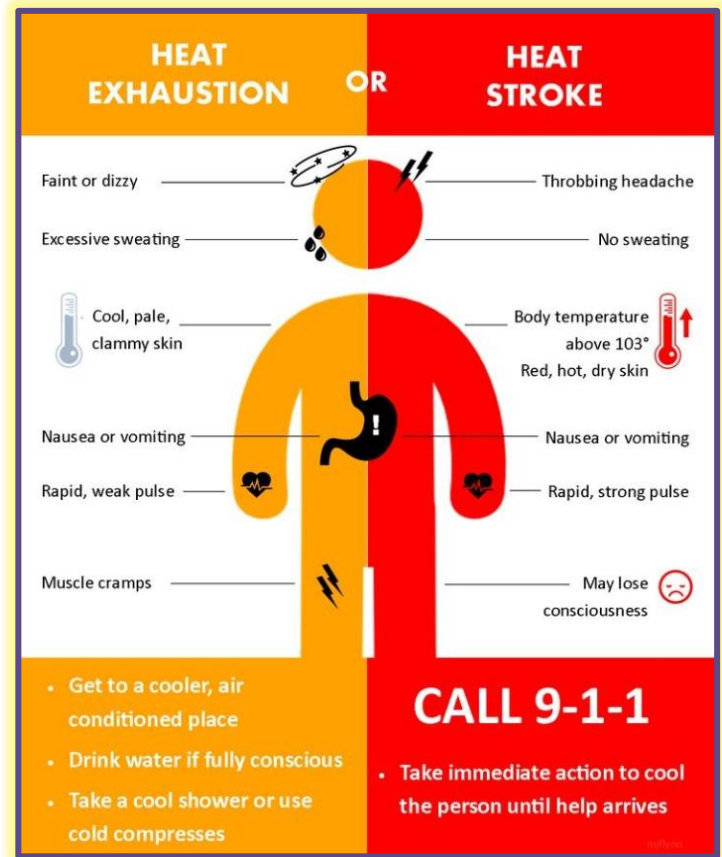
## PHOENIX SUMMER HEAT SAFETY



Do you know what triggers an excessive heat warning? An **Excessive Heat Warning** is issued by the [National Weather Service](#) when there is a *High* or *Very High Heat Risk*. During periods of excessive heat, it's best to remain indoors. Should you find yourself outside in the elements, here's how to protect yourself:

- When possible, utilize indoor facilities that accommodate physical activity
- Plan outdoor activities for the coolest times of the day
- Limit and reduce duration of outdoor activity
- Take frequent breaks
- Provide drinking water before, during, and after the activity
- Drink more water than usual. Avoid drinks with sugar, alcohol and caffeine
- Pace physical activity
- Plan for cool-down recovery time in the shade if possible following an outdoor activity
- Wear light colored clothing, wide-brimmed hats

If you are outdoors, know the signs of heat exhaustion. Are you feeling faint or dizzy? Are you pale or is your skin clammy? See the warning signs below.

## PHOENIX FIRE DEPARTMENT SUMMER WATER SAFETY

Drowning is one the leading causes of death of children under the age of four. It takes just seconds for a child to drown. Most children drown in their own pools, but many children drown in canals, buckets, toilets, bathtubs and ponds. Too often, firefighters hear people say, "I only turned my back for a few seconds." Sadly, just a few seconds is all it takes for a child to drown.

Non-fatal incidents are also tragic. Non-fatals can cause permanent brain damage. Drowning and non-fatal incidents can be prevented! Anyone involved with young children needs to be aware of this potential tragedy.

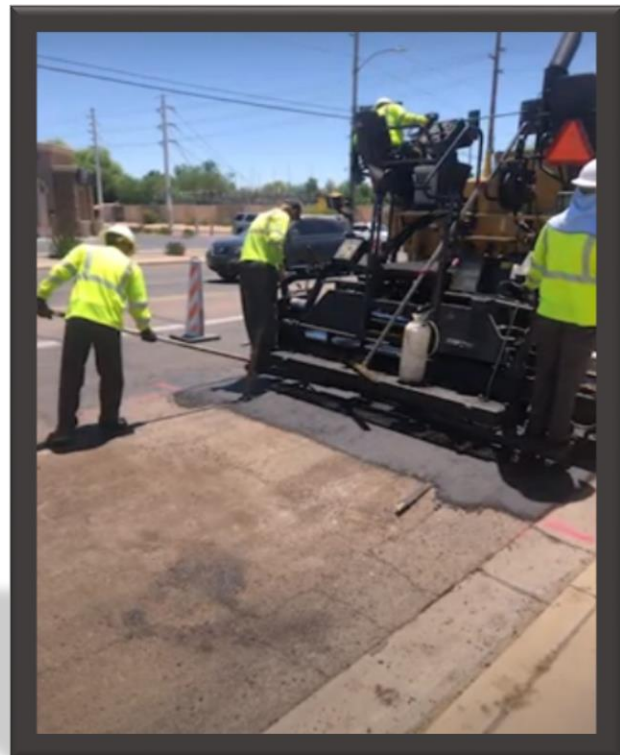


## STREET TRANSPORTATION DEPARTMENT

## PHOENIX AVIATION DEPARTMENT BEGINNING JUNE 1: MASKS REQUIRED AT SKY HARBOR



**Effective June 1, 2020 Phoenix Sky Harbor International Airport will require all employees and members of the public entering public airport facilities, including the terminals, the Rental Car Center, the PHX Sky Train®, and Airport buses to wear a face covering.**

In concert with major airlines, the TSA, airports across the country including Seattle, Denver, LAX, New York's JFK, Boston Logan, Miami, and even companies such as Uber, everyone in public airport facilities will be required to cover their noses and mouths.

Travelers, employees, and those visiting the airport should bring their own face covering to wear throughout the airport. Several airport stores are currently selling masks, with more stores to offer additional options soon.

The face covering does not have to be commercially purchased. It can be a homemade cloth mask, or bandana – as long as the requirement is met to cover the nose and mouth. The CDC [has instructions on how to create and wear a cloth face covering](#).

Exceptions to this requirement include:

- Children two years of age or younger
- Any child age 12 years or less unless parents and caregivers supervise the use of face coverings, or any individual who has a physical disability that prevents easily wearing or removing a face covering
- Any individual who is hearing impaired and uses facial and mouth movements as part of communication, or it is necessary for communicating with an individual using facial and mouth movements to share information
- Individuals consuming food or beverages
- Individuals who are unable to wear a face covering due to a medical condition
- When necessary for identification verification purposes
- When necessary for taking photographs for Aviation Credentialing/Security Badging purposes.

Sky Harbor will continue to maintain a thorough 24-hour cleaning schedule. The number of times per day high-touch areas are sanitized was increased at the onset of the COVID-19 global health pandemic, and these vigilant sanitation efforts will remain in place.

Here are some of the manners in which the airport will ensure that health and safety is at the forefront of operations:

- Physical distance markers have been installed appropriate in the facilities and more will be added in queue lines.
- Hand sanitizer dispensers are available for all customers and employees.
- Plexiglass has been installed at Information Counters to create a seamless but effective barrier between staff and customers.
- Physical distancing is encouraged with overhead announcements, messaging on flight information displays, and additional signage.
- Passengers will be asked to limit the number of people on Rental Car Center buses and in the PHX Sky Train® cars to 10 individuals per vehicle and to stand back from the doors to allow others to exit.
- Shops will have new protocols in place. For many, this includes additional signage, barriers and queuing markers, increased sanitation, limiting the number of people in stores, and encouraging touchless transactions.
- Restaurants that have fully re-opened have re-configured seating for physical distancing. Many remain open for take-out only at this time.
- Safety signage/messaging is being placed at entryways, PHX Sky Train®, buses, and on our website.

How travelers can prepare for the travel experience at Sky Harbor:

- Give yourself extra time.
- Practice physical distancing at all times.
- Wash your hands frequently.
- Use a mobile boarding pass.

# **PUBLIC TRANSIT CAPITOL/I-10 WEST LIGHT RAIL EXTENSION ONLINE PUBLIC MEETING**



Valley Metro and the city of Phoenix invite the public to attend an online public meeting for the latest update on the Capitol/I-10 West Extension. The Transportation 2050 funded light rail extension will ultimately connect riders from the current Valley Metro Rail system to the state capitol and west Phoenix.

The online presentation will include an overview of the preferred downtown route based on feedback gathered from the public in January 2020. Additional comments will be requested regarding the type of transit for the section between the state capitol and 79th Avenue, and whether the route should be extended from 79th Avenue to Desert Sky Mall.

## PHOENIX WATER SERVICES DEPARTMENT

### Extending the Life of N95 and Surgical Masks for Reuse

As the need for N95 and surgical masks continue to rise, equipment in the Phoenix Water Services water quality laboratory is being used to disinfect masks and eliminate any SARS-CoV-2 with Ultraviolet (UV) light. The UV light disinfects the masks without destroying them, which allows staff to reuse them.



According to the [National Institutes of Health](#), UV light, dry heat, and ethyl alcohol can also be used to sanitize masks. Phoenix Water utilizes UV light as a part of its daily functions and created a process to properly sanitize the masks and ensure that all safety regulations are being followed. Staff used biological indicators to test the effectiveness of the UV lights. If nothing grows on the biological indicators, the team would know that the masks had been sanitized.

Phoenix Water staff take extra precautions before, during, and after the process including wearing PPE, and cleaning and disinfecting the work surfaces. The mask owner is responsible for adequately labeling the mask with their name. They then place the dirty mask in a paper bag, also labeled with their name, folded over, and stapled shut. The bag goes into a sealed container, or bin, labeled as "Dirty Masks" and includes the division's name where the staff works. The container is submitted to ESD to be sanitized. The container is also cleaned with disinfectant once emptied and returned. An inventory list is kept of all the masks owners inside the "Dirty Mask" bin and inside the "Clean Mask" bin.

Once all the masks and containers have been sanitized, the entire room is sanitized with the same UV light. The whole process takes a couple of hours and can be done as often as needed.

## **PHOENIX POLICE DEPARTMENT Mental Health Emergency Services**

May is Mental Health Awareness Month and all month, Phoenix Police have shared the ways to address mental health in the department and in the community. As the month comes to an end, the department virtually shares how they are looking at the resources that are available to respond out when a mental health call comes in.



If a mental health call is an imminent threat, officers will be dispatched and when possible, a Crisis Intervention Team, or CIT, officer will be sent. These are Phoenix Police officers that have voluntarily gone through 40 hours of training in mental health and the services available to help. About 20 percent of the Phoenix Police Department is CIT certified.

When a call comes in and is not an imminent threat, a larger crisis system can be tapped into. The call will be passed on to the 24-hour county crisis line who can handle the call over the phone or send a mobile team. The mobile team is made up of crisis specialists with counseling and social work experience. These teams are trained to get people connected to the level of care they need from responding on scene to getting people to a rehab program, counselor, or behavioral health hospital.

## ADOT: WEEKEND RESTRICTIONS



### Overnight lane restrictions scheduled on Interstate 17 between Pinnacle Peak and Happy Valley Roads

Drivers who use Interstate 17 in north Phoenix should expect overnight lane restrictions as reconstruction of the interchanges at Pinnacle Peak and Happy Valley roads continues.

The Arizona Department of Transportation advises drivers to slow down and use caution around construction personnel and equipment while these restrictions are in place:

- Northbound I-17 will be narrowed to two lanes between Pinnacle Peak and Happy Valley roads from 9 p.m. Friday, May 29, to 5 a.m. Saturday, May 30.
- Southbound I-17 will be narrowed to one lane between Happy Valley and Pinnacle Peak roads at the same time.

No work that will impact traffic is scheduled over the weekend, however nightly lane restrictions are set to begin late Sunday, May 31, and continue all week as follows:

- North and southbound I-17 will be narrowed to one or two lanes at Happy Valley Road nightly from 9 p.m. to 5 a.m. from Sunday night through the morning of Saturday, June 6.
- The southbound I-17 frontage road will be narrowed to one lane south of Pinnacle Peak Road nightly from 9 p.m. to 5 a.m. from Sunday night through the morning of Friday, June 5.

**Reminder:** The I-17 travel lanes between Pinnacle Peak and Happy Valley roads are narrowed to 11 feet.

The new Pinnacle Peak Road interchange is scheduled to open later this summer. The project is scheduled for completion this fall. Learn more by visiting the [project website](#).

The City of Phoenix Water Services Department has contracted with Achen-Gardner Construction to perform water line related construction in preparation for ADOT's future storm drain project at Greenway Road & I-17.

Drivers should plan to use detours and allow extra travel time while the following restrictions are in place:

- Eastbound Greenway Road will be closed between 29th and 25th avenues from 9 p.m. Friday, May 29, to 5 a.m. Monday, June 1 and again from 9 p.m. Friday, June 5, to 5 a.m. Monday, June 8.
- The northbound I-17 Greenway Road off-ramp will be closed, and the northbound frontage road will be closed at Banff Lane.
- The southbound I-17 off-ramp will be restricted to allow only right turns onto Greenway Road.
- Drivers on westbound Greenway Road will not be able to turn left onto the southbound I-17 ramp. The northbound on-ramp will be accessible for westbound drivers.

**Detours:** Drivers should consider using Bell or Thunderbird roads for east-west travel and to enter and exit I-17.

ADOT is constructing improvements to the cross-street drainage system on I-17 between Greenway Road and Dunlap Avenue. Visit the [ADOT project webpage](#) to learn more.

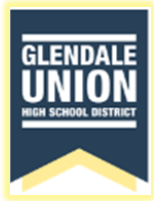
