**Eligibility & Application**

Artist Must Be:

- At least 18 years old (*except for Ambitions: Teen Art Show & Extravaganza Kids Summer Art Show*)
- Each application packet must be submitted in one large envelope.
- Submissions must consist of original artwork completed within the last two years.
- The number of pieces selected for each exhibition will be at the discretion of the Phoenix Center for the Arts staff.
- Artists will be accepted based on quality factors including exhibition space.

**Phoenix Center Gallery Will Provide**

- Notification to artist by mail of acceptance status. Please do not call for results.
- First Friday opening reception featuring refreshments, live entertainment, art detour trolley stop, etc.
- Installation of artwork.
- Scheduled staff for technical assistance and monitoring during regular gallery hours.
- Press release, publications, and postcards.

**Individual Artist Application/Exhibition Fee**

- Application fee of \$40\* for each individual artist (***No commission taken on sold art work***)
- Checks made payable to the City of Phoenix.
- Fee is nonrefundable

*\*Ambitions: Teen Art Show and Extravaganza Kids Summer Show do not have application fees*



## Artist Responsibility

- After selected, work must be hand-delivered or shipped no later than the due date. Please refer to show for due dates.
- The Phoenix Center for the Arts is not responsible for artwork left beyond the last scheduled pick-up date, unless previously arranged.
- Artist must provide the Phoenix Center for the Arts with high resolution digital images of artwork for publicity purposes.
- All artwork must be ready for installation.
- Artist is responsible for all shipping expenses (delivery and pick-up).

## Terms

- Fees are non-refundable.
- Incomplete submissions will be not accepted.
- The Phoenix Center for the Arts is not responsible for contacting artist if the submission is not complete.
- CD or other electronic media that do not open will result in an incomplete submission
- The Phoenix Center for the Arts is not responsible for items once picked up by US Mail or other carrier service.
- Please do not include extra materials such as postcards or brochures.
- **All decisions by jury are final.**
- Insufficient fee results in an incomplete submission.
- The Phoenix Center for the Arts has the right to use images of accepted art for promotional purposes.
- Artwork must be ready for display.
- All information is subject to change.
