# **NOTICE OF ELECTION**

On Tuesday, March 12, 2019, a Special Election will be held for registered voters residing in the City of Phoenix to elect a Mayor to serve the remainder of a term that expires April 19, 2021. The Runoff Election is required by the City Charter because no mayoral candidate received a majority of the votes cast in the Special Election held on Nov. 6, 2018. The Special Election is also to fill two vacancies on the City of Phoenix Council. Voters residing in Council District 5 will elect a Councilmember to serve the remainder of a term that expires April 19, 2021. Voters residing in Council District 8 will elect a Councilmember to serve the remainder of a term that expires April 17, 2023.

### **Early Voting**

City voters on the Permanent Early Voting List (PEVL) will automatically receive an early ballot by mail unless they submit a request to not receive a ballot by mail to the City Clerk by Wednesday, Jan. 16. Voters who are not on the PEVL may submit a signed written request for an early ballot by mail. Request forms are available online at <a href="Phoenix.gov/Elections">Phoenix.gov/Elections</a>, at City public service counters and City libraries or by calling the telephone number listed below. Early ballots will be mailed beginning Wednesday, Feb. 13. In-person early voting also will be available from Wednesday, Feb. 13 through Friday, March 8, during normal business hours on the 15th floor of Phoenix City Hall. The City Clerk must receive a voter's signed request for an early ballot by mail no later than Friday March 1, 2019.

#### **Voting at Voting Centers**

The City of Phoenix will be using voting centers for this election. Voters are not required to vote at a specified polling place in the voter's precinct for this election. Any City voter can use any one of the voting centers to cast a ballot. For voting convenience, the voting centers will be open on Saturday, March 9 from 10 a.m. until 4 p.m., on Monday, March 11 from 9 a.m. until 6 p.m., and from 6 a.m. until 7 p.m. on Election Day, Tuesday, March 12. VOTERS WHO DO NOT VOTE BY MAIL ARE ENCOURAGED TO VISIT THE VOTING CENTERS ON SATURDAY, MARCH 9 AND MONDAY MARCH 11 TO VOTE IN THE SPECIAL ELECTION, as these days are less busy.
