

# AUGUST 2019 SPECIAL ELECTION

## NOTICE OF ELECTION

On Tuesday, Aug. 27, 2019, registered voters residing in the City of Phoenix will vote on two ballot measures in a Special Election. The first measure is a proposed Charter Amendment related to Light Rail. A second measure is a proposed Charter Amendment related to Pension Reform.

### Important Dates

- Earliest date to request a ballot by mail .....April 29, 2019 (Monday)
  - Latest date to file ballot measure arguments .....May 29, 2019 (Wednesday)
  - Sample Ballot and Publicity Pamphlet is mailed .....July 22, 2019 (Monday)
  - Latest date to register to vote .....July 29, 2019 (Monday)
  - Early voting and mailing of early ballots begins .....July 31, 2019 (Wednesday)
  - Latest date to request a ballot by mail .....August 16, 2019 (Friday)
  - Last day to vote at early voting sites .....August 23, 2019 (Friday)
  - ELECTION DAY .....August 27, 2019 (Tuesday)
- Last day to vote at a voting center

### Early Voting

City voters on the Permanent Early Voting List (PEVL) will automatically receive an early ballot by mail unless they submit a request to not receive a ballot by mail to the City Clerk by Wednesday, July 3. Voters who are not on the PEVL may submit a signed written request for an early ballot by mail. Request forms are available online at [Phoenix.gov/Elections](http://Phoenix.gov/Elections), at City public service counters and City libraries or by calling the telephone number listed below. Early ballots will be mailed beginning Wednesday, July 31. In-person early voting also will be available from Wednesday, July 31 through Friday, August 23, during normal business hours on the 15th floor of Phoenix City Hall. The City Clerk must receive a voter's signed request for an early ballot by mail no later than Friday, August 16, 2019.

### Voting at Voting Centers

The City of Phoenix will be using voting centers for this election. Voters are not required to vote at a specified polling place in the voter's precinct for this election. Any City voter can use any one of the 28 voting centers to cast a ballot. For voting convenience, the voting centers will be open on Saturday, August 24 from 10 a.m. until 4 p.m., on Monday, August 26 from 9 a.m. until 6 p.m., and from 6 a.m. until 7 p.m. on Election Day, Tuesday, August 27. **VOTERS WHO DO NOT VOTE BY MAIL ARE ENCOURAGED TO VISIT THE VOTING CENTERS ON SATURDAY, AUGUST 24 AND MONDAY, AUGUST 26 TO VOTE IN THE SPECIAL ELECTION**, as these days are less busy. A list and map of the voting centers will be available online at [Phoenix.gov/Elections](http://Phoenix.gov/Elections) and in the Sample Ballot and Publicity Pamphlet (SBPP).
