## Re: Evaluation by City of Phoenix Ethics Committee Elected Official – City Councilman Carlos Garcia

Ms. Archibald;

On October 28, 2019 City Manager Zuercher directed me (*see attached*) to submit the following request to you to come into compliance with Phoenix City Code Section 2-1005.01 C.

On or around October 16, 2019 an ABC15 Arizona News report documented on video a police contact between ASU Campus Police and City of Phoenix Councilman Carlos Garcia. The link to the news item is below:

The Ethics Handbook for Elected Officials states: "Any person who is a Phoenix resident or who is directly aggrieved by an act or the failure to act of an elected official or board member may file with the City Clerk a written inquiry containing specific allegations of violations of the City's ethics or gift policy by any elected official or board member."

According to the ABC15 report, the two officers initially asked Mr. Garcia for his identification, vehicle registration and insurance information. After having provided the officers what was requested, Mr. Garcia stated, "Do you want to see who I am?" Mr. Garcia also said to the on-duty officers, "I just need to look into this more to figure out how to get you guys out of here." On the video, these comments appeared to illicit a baffled response from one of the officers.

The Ethics Handbook also states: "Phoenix City Code Chapter 2, Article II, Section 2-52(B) (Ethics Policy) B. Ethics policy. It is the policy of the City of Phoenix to uphold, promote and demand the highest standards of ethics from all of its elected officials, employees, board members, and volunteers. Accordingly, all City elected officials, employees, board members, and volunteers must maintain the utmost standards of personal integrity, truthfulness, honesty and fairness in carrying out their public duties, avoid any improprieties in their roles as public servants (*emphasis mine*), and never use their City position or power for improper personal gain (*emphasis mine*)."

There is a concern a traffic stop like this involving a City Councilperson confronting a Police Officer is a veiled threat - the use by an elected official of their position or power for personal gain. In this instance the personal gain may be to avoid a citation. I would greatly appreciate your consideration in tasking/requesting the City's Ethics Commission to make an inquiry into this matter. Seeing that Councilman Garcia took the time to speak with the ASU Police Chief regarding this contact, it might not be unreasonable if the Ethics Panel engage and communicate with the two involved officers about the interaction.
