Supporting Analysis: Comparison of Whitaker Group's Race, Culture, Procedural Justice and Police Legitimacy training for the City of Phoenix with Chicago Police Department's Procedural Justice and Police Legitimacy Training

Content Duplication Comparison:

Five of the six Whitaker Group (WG) modules are drawn virtually slide for slide and in most cases word-forword from the Chicago Police Department (CPD) Procedural Justice and Police Legitimacy training material presentation. The Whitaker Group's training material total 84 slides, of which 52 are copies or have minor modifications. Each of the slides in The Whitaker Group's presentation had an individual copyright on each page, regardless of whether it was an exact copy of the Chicago Police presentation. The Whitaker Group's copyright was on work that was not Professor Whitaker's own work.

A breakdown of each slide:

- 52 slides of Professor Whitaker's training materials are either exact copies or with minor changes.
- 12 are pictures
- 13 are non-content pages such as a welcome page and title pages
- 7 are original content

Billing History:

Professor Whitaker invoiced the City of Phoenix and was paid 3 times. In those three invoices, he attempted to bill the City of Phoenix for a total of 109 hours for course preparation and revision; which at his \$350 billing rate would total \$38,150. That billing was for work that was largely copied from the Chicago training document and although it bore the Whitaker Group's copyright; was not truly Professor Whitaker's own work.

- First invoice #1229, dated April 21, 2015 for 28 hours of work, for the dates of February 10-20, 2015 and paid \$8,500. Purpose: preparation of the Cultural Competency Procedural Justice, and Police Legitimacy Module
- 2. Second invoice #1230 dated May 29, 2015 for 143 hours, for the dates of December 11, 2014 to May 29, 2015. Invoice total was \$50,150. Of the 143 hours, 75 hours were billed for outline preparation, outline revision, research reading and notation. After an inquiry by the City regarding the billing period predating the contract date and the total amount of the this invoice being so high that Professor Whitaker was going to exceed the total contract amount well before the term; Professor Whitaker was paid for 32 hours of course preparation time for this invoice.
 - a. Professor Whitaker billed for work dating back to December 11, 2014, before any formal agreement was reached with city staff. Email dated May 21, 2015 from city staff cautioned Professor Whitaker that charging for so much preparation time risked exceeding the amount of the contract before completion.
 - i. In the same email chain, dated 5-21-15, Professor Whitaker responded to city staff: "Please note that I had to devote many front-loaded hours to research, design, preparation, and presentation of the Cultural Competency module."

Same email dated 5-21-2015: City staff asked for clarification of hours that Professor Whitaker billed for preparation time versus class time. Ultimately the City approved work done from April 5 - May 29, 2015 which totaled 95.5 hours and paid \$33,525 of the \$50,150. Of the 95.5 hours approved, 32 of those hours were broken into 16 hours of research, reading, and notation; and the other 16 hours were comprised of module outline and PowerPoint presentation preparation.

3. The third and final invoice #1231 dated May 29, 2015 for 38 hours of work, for the dates of June 1-30, 2015, and was paid \$13,300. Of the 38 hours, Professor Whitaker billed 4 hours for research and reading, and 2 hours of module media review and revision.

Content Duplication Comparison:

Professor Whitaker's first module seems drawn from a presentation on "Understanding Culture and Building Community" he has often given. Here are examples of congruence "PDF" refers to the PDF beginning with the Whitaker slide presentation:
