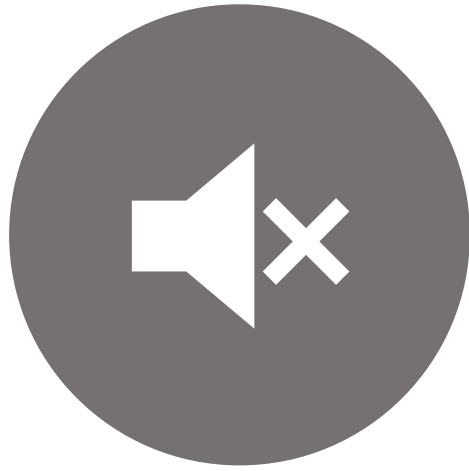

# What is PRO Housing?

- Pathways to **Removing Obstacles to Housing**
- Competitive funding opportunity from the U.S. Department of Housing and Urban Development (HUD)
- Evaluate and implement housing policy plans, improve housing strategies, and support affordable housing production and preservation

# What is PRO Housing?

- NOFO released August 13, 2024
- Applications due October 15, 2024
- \$100 million in total funding with 30 estimated awards
  - \$1 million minimum / \$7 million maximum grant size
- Estimated grant period: Early 2025 – September 2030
