


## Our Office in Context

- Overseeing Opioid Settlement dollars


Naloxone Kits

- Over 30 city facilities receiving naloxone free of charge for staff and community members alike
- Recently launched an open-data dashboard that tracks overdoses, overdose deaths, and EMS calls responding to suspected overdoses
  - Builds direction for where the office should be focusing efforts




#### Number of Suspected Opioid Overdoses in Phoenix (Year-to-Date)

## Number of Fatal Overdoses in Phoenix




- **39%** increase in fatal overdose rate 2019-2022
- **1.8** times County Rate
- **1,023** Fatal overdoses (2022)
- **54%** of the county total




#### 2022: Fatal Overdoses Demographics



## 1-year Activities 2025-2026 Goals 1-4

- Prevent Substance Use-Related Death and Disease
  - Naloxone Distribution and Training for Phoenix Community
- Reduce Barriers to Treatment and Recovery
  - Screening and referral process for outreach staff
- Prevent Youth Substance Use and Addiction
  - Partnerships with K-12 settings for prevention programs
- Strengthen City of Phoenix Behavioral Health Crisis Responses
  - Existing teams within the City of Phoenix engaging in responses



# 1-year Activities 2025-2026 Goals 4-8

- Reduce Stigma Associated With Substance Use Disorder
  - Communication campaigns for broader Phoenix community
- Increase Coordination & Collaborative Partnership
  - Advisory Committee for community representatives
- Invest in Data Monitoring & Program Evaluation
  - Phoenix Substance Use and Overdose Dashboard
- Understand and Influence the Policy Landscape
  - City policies that impact people accessing services such as housing, shelter, treatment
