**PLANNED MAJOR STREET RESTRICTIONS AND CLOSURES - UPDATED APRIL 13**

Motorists are advised to be aware of the following planned major roadway restrictions and closures.

**NEW RESTRICTIONS:**

**FIRST STREET AND POLK STREET INTERSECTION**

Northbound First Street is scheduled to be **closed** between Van Buren and Polk streets.

Alternating lane closures will apply to eastbound and westbound Polk Street from Central Avenue to First Street between 6 a.m. and 4 p.m., Saturday, April 14.

Local, business and Arizona State University parking garage access will be maintained.

This closure is required to accommodate roadway resurfacing work.

**GLENDALE AVENUE – 14TH STREET TO 17TH STREET**

Glendale Avenue from 14th Street to 17th Street is scheduled to be restricted, on a 24-hour basis, beginning at 3 a.m. Sunday, April 15 through Sunday, May, 27.

Eastbound and westbound Glendale Avenue will be restricted to two lanes on a 24 hour basis.

Westbound Glendale Avenue will be restricted to a single lane between 9 a.m. and 3 p.m.

Bus stop number 14573 will be temporarily relocated west to bus stop number 14574.

Business and pedestrian access will be maintained.

Police officers may be onsite to assist with traffic control during construction.

These restrictions are required to accommodate a Southwest Gas main project, the hotline number is 602-532-6100.

### INDIAN SCHOOL ROAD AND 7TH STREET

Lane restrictions will apply to Indian School Road at 7th Street starting at 6 a.m. Monday, April 16 through Saturday, May 5.

Two lanes will be kept open on eastbound and westbound Indian School Road.

Left-turns on eastbound and westbound Indian School Road will remain restricted at 7<sup>th</sup> Street.

A single lane restriction will apply northbound 7th Street.

All lane restrictions will remain in place on a 24-hour basis.

Local and business access will be maintained.

These restrictions are required to accommodate bus bay construction work.

### INDIAN SCHOOL ROAD – 17TH STREET TO 19TH STREET

Indian School Road between 17<sup>th</sup> and 19<sup>th</sup> streets is scheduled to be restricted, on a 24-hour basis, beginning at 7 p.m. Friday, April 13 through 5:30 a.m. Monday, April 16.

Alternating lane restrictions will apply to eastbound and westbound Indian School Road and the SR-51 off-ramps will be **closed**.

Pedestrian access will be maintained.

Police officers may be onsite to assist with traffic control during construction.

These restrictions are required for the installation of a new water main, the hotline number is 602-956-2670.

### MCDOWELL ROAD – 36TH STREET TO 44TH STREET

McDowell Road from 36th Street to 44th Street is scheduled to be restricted from 8:30 a.m. to 4 p.m. Monday through Friday; and 7 a.m. to 6 p.m. during weekends beginning Monday, April 16 through Friday, June 15.

McDowell Road will be restricted to two lanes eastbound and one lane westbound Monday through Friday and one lane in each direction during weekends.

41st Place will be **closed** from McDowell Road to Almeria Road on a 24-hour basis as needed.

Almeria Road may be **closed** to local traffic on a 24-hour basis as needed.

Pedestrian access will be maintained.

Police officers may be onsite to assist with traffic control during construction.

These restrictions are required for the installation of a new storm drain, the hotline number is 480-281-1506.

#### 15TH AVENUE – ORANGEWOOD AVENUE TO GLENDALE AVENUE

15th Avenue between Orangewood and Glendale avenues is scheduled to be **closed** starting at 6 a.m. Saturday, April 14 through 6 p.m. Sunday, April 15.

Local access will be maintained on 15<sup>th</sup> Avenue between Myrtle and Glendale avenues.

This closure will be required for the installation of a new water line.

#### 19TH AVENUE – HAPPY VALLEY ROAD TO JOMAX ROAD

Southbound 19<sup>th</sup> Avenue between Happy Valley and Jomax roads is scheduled to be **closed** 7 a.m. to 5 p.m. Saturday, April 14.

The closure will be required to accommodate a water line installation for a private development project.

#### 35TH AVENUE AND VAN BUREN STREET

The intersection of 35<sup>th</sup> Avenue and Van Buren Street will remain restricted through Monday, April 23.

Local and business access continues to be maintained.

Expect delays when traveling through the area.

This restriction is required for the placement of a temporary traffic signal.

#### 59TH AVENUE – BUCKEYE ROAD TO VAN BUREN STREET

59<sup>th</sup> Avenue between Buckeye Road and Van Buren Street is scheduled to be **closed** overnight from 7 p.m. to 5 a.m. Monday, April 23 through Thursday, April 26.

Through northbound traffic will be detoured at Buckeye Road to 51<sup>st</sup> Avenue and 67<sup>th</sup> Avenue.

Through southbound traffic will be detoured at Van Buren Street to 51<sup>st</sup> Avenue and 67<sup>th</sup> Avenue.

Local and business access will be maintained.

These restrictions are required for construction related to the Loop 202 / South Mountain Freeway Project. Connect 202 Partners is managing the project.

#### 59TH AVENUE – MCDOWELL ROAD TO I-10 FREEWAY

59<sup>th</sup> Avenue between McDowell Road and the I-10 Freeway is scheduled to be **closed** overnight starting at 4 a.m. Saturday, April 21 through 4 p.m. Sunday, April 22.

Through southbound traffic will be detoured at McDowell Road to 67<sup>th</sup> Avenue and 51<sup>st</sup> avenues.

Northbound 59<sup>th</sup> Avenue will remain open to through traffic.

Westbound I-10 Freeway access will be maintained.

Local and business access will be maintained.

These restrictions are required for construction related to the Loop 202 / South Mountain Freeway Project. Connect 202 Partners is managing the project.

#### 67TH AVENUE – LATHAM STREET TO I-10 FREEWAY

Northbound 67<sup>th</sup> Avenue between Latham Street and the I-10 Freeway is scheduled to be **closed** overnight 7 p.m. to 5 a.m. Wednesday, April 18 through Friday, April 27.

Traffic on northbound 67<sup>th</sup> Avenue will be detoured at Van Buren Street to 59<sup>th</sup> and 67<sup>th</sup> avenues.

Southbound 67<sup>th</sup> Avenue will remain open.

Eastbound I-10 Freeway access will be **closed** at 67<sup>th</sup> Avenue.

Local and business access will be maintained along 67<sup>th</sup> Avenue between Van Buren and Latham streets.

These restrictions are required for construction related to the Loop 202 / South Mountain Freeway Project. Connect 202 Partners is managing the project.

### BIKE TO WORK DAY

This event will take place at CityScape at 7 a.m. Wednesday, April 18.

The following street will be **closed** from 5:30 a.m. through 10 a.m.:

- Central Avenue – Washington to Jefferson streets (CityScape)

During this event, Central Avenue through traffic will be detoured at Jefferson Street to Second Street.

All streets will open to normal traffic by 10 a.m. Wednesday, April 18.

### CITYSCAPE – SAVOR ON CENTRAL

This event will take place at CityScape at 6 p.m., Thursday, April 19.

The following street will be **closed** from 11 a.m. through 11 p.m.:

- Central Avenue – Washington to Jefferson streets (CityScape)

During this event, Central Avenue through traffic will be detoured at Jefferson Street to Second Street.

44<sup>th</sup> Street – Pinnacle Peak Road to Casitas del Rio Drive

Peoria Avenue at 19<sup>th</sup> Avenue

### **CONTINUING RESTRICTIONS:**

- Broadway Road “Avenida Rio Salado” – Seventh Street to 51<sup>st</sup> Avenue, intermittent partial restrictions to accommodate a city of Phoenix Street Transportation Department capital improvement project. This closure/restriction is scheduled to be removed February 2019. - Buckeye Road – 59th Avenue to 63rd Avenue, partial restriction to accommodate a Southwest Gas project. This restriction is scheduled to be removed in April.

- Glendale Avenue - 15<sup>th</sup> Avenue to 7<sup>th</sup> Avenue will remain restricted through Sunday, April 29. These restrictions are required for the installation of gas main.
- Loop 202 (South Mountain Freeway) construction project: 59<sup>th</sup> Avenue – Interstate 10 to Estrella Drive and Pecos Road - 48<sup>th</sup> Street to 59<sup>th</sup> Avenue, intermittent detours to accommodate the Arizona Department of Transportation Loop 202 Freeway Project. This closure/restriction is scheduled to be removed in November 2019. - Southern Avenue – 59<sup>th</sup> Avenue to 67<sup>th</sup> Avenue, **full closure** to accommodate the Arizona Department of Transportation Loop 202 Freeway Project. This closure/restriction is scheduled to be removed in March. - Washington and Jefferson streets – First to Second streets, partial restrictions to accommodate a private development project overseen by the city of Phoenix Planning and Development Department. This closure/restriction is scheduled to be removed in December 2019.
- Washington Street – 48<sup>th</sup> Street to 51<sup>st</sup> Street, daytime partial restriction to accommodate a Valley Metro Light Rail station construction project. This closure/restriction is scheduled to be removed in May 2019.
