### **HELLO FROM ENVIRONMENTAL SERVICES DIVISION (ESD):**

The Environmental Services Division (ESD) ensures that City water and wastewater facilities protect public health and the environment by maintaining compliance with environmental laws, and by providing high-quality and reliable services to the Department, City staff, and the public.

ESD consists of various sections:

**BUSINESS OPERATIONS:** Administrative, community outreach, laboratory safety, and environmental training coordination.

**COMPLIANCE:** Air, hazardous material, wastewater, and water regulatory compliance.

LABORATORY: Analytical testing of water and wastewater. Licensed by the Arizona Department of Health Services (ADHS) and certified by The National Environmental Laboratory Accreditation Program (NELAP).

MONITORING: Monitoring and sampling of water and wastewater accredited by The National Environmental Field Accreditation Program.

POLLUTION, PREVENTION, & PERMITTING: Commercial, Industrial Pretreatment, and Stormwater programs conduct inspections, prevention, permitting, and sampling.

**QUALITY ASSURANCE:** Quality assurance, compliance and monitoring. **SAFETY:** Safety oversight and training for all Water Services Department employees.

The City of Phoenix Industrial Pretreatment Compliance Academy was established to inform and educate permitted industrial facilities on the importance of and how to

## IF YOU SEE SOMETHING, SAY SOMETHING!

Environmental Services Division staff is responsible for ensuring the City maintains compliance with various permits the City operates under issued by Arizona Department of Environmental Quality, Maricopa County and other governmental agencies. Non-compliance with these permits can cause the City to be in violation of a permit and potentially fined. To ensure compliance, staff from the Environmental Services Division are constantly out in the field conducting facility inspections and complaint investigations. Did you know you can easily report a complaint to ESD staff?

If you see or suspect someone is illegally dumping pollutants into the sewer or storm drain, please report it to us. We will investigate and mitigate the issue. We will conduct any complaint investigations anonymously and will not disclose the source of the complaint. ESD staff will also follow-up and report the findings of our investigation if you want. However, if the activity appears criminal or you do not feel safe reporting, call 911 immediately.

Illegal pollutants dumped down the stormdrain will end up in your local retention basin or nearby river, UNTREATED! Illegal pollutants dumped down the sewer can affect the treatment process. Illegally dumped pollutants can negatively impact our drinking water sources!

# NATIONAL PRESCRIPTION DRUG TAKE BACK DAY IS APRIL 27, 2024!

The Federal Drug Enforcement Administration launched National Prescription Take Back Day in 2010 to provide a safe way for Americans to dispose of their unused prescription drugs in a safe, legal, and environmentally sound way. The proper disposal of pharmaceuticals is an important public health issue. There are concerns that unused medications can be misused. Another concern is the impact improper disposal can have on the environment. A common method of disposal is to flush pharmaceuticals down the toilet to prevent them from falling into the wrong hands. However, pharmaceuticals are engineered to remain stable as they are absorbed by the human body; as a result, they also remain stable while traveling through the sewer system. Most wastewater treatment plants are not designed or equipped to remove or break down pharmaceuticals, so they are able to pass through the treatment process and end up in the environment.

### Don't rush to flush! Dispose of pharmaceuticals properly:

• Take unused medication to an official drug take-back site or event. Find a location near you at: the Drug Enforcement Administration Controlled Substance

Public Disposal Locations website.

• Dispose of pharmaceuticals at a City of Phoenix Department Drop Boxes located in the lobby of Police Department Precincts (note: needles, sharps, aerosols, inhalers, medical waste, lotions, liquid medicines, and thermometers are not accepted).

The last Take-Back Day took place October 28, 2023, where 300 tons of unused medications were collected for disposal from 4675 collection sites nationwide.
